- A. The EHA Annual Congress is the premier hematology congress in Europe, covering all subspecialties in hematology. The educational and scientific program highlights state-of-the-art clinical practice, the latest findings in hematology research and many more interesting sessions. The EHA Congress also acts as a forum for original data, hematological innovation and evidence-based knowledge of primary clinical relevance.

6. In the EHA2025 Congress, and, in so far as reasonably possible in the EHA Communications, I will be credited as author or co-author. I acknowledge that EHA may accomplish the publication of the EHA2025 Congress through one or more designated contractors or representatives performing services on EHA's behalf (**"Designee"**).
7. I understand that my permission will entitle EHA to store my Contribution on servers and other hosting platforms under control of EHA, and/or a Designee.



8. I represent and warrant that my Contribution is original and that I am the author and legally entitled to grant this permission, and that I am not bound by any restrictions from third parties, such as research institutes, my employer, co-authors, sponsors or financiers.
9. Because neither EHA, nor any Designee will be making any changes in the substance of the Contribution, except for necessary redaction, technical manipulations and language changes required for accurate translation, neither I nor anyone acting on my behalf shall hold EHA, nor any Designee liable for any claims, actions or damages resulting from the publication, viewing or use of my Contribution in the EHA2025 Congress.
10. Should this become necessary at any point in time, for instance in the event of enforcement against infringement, I shall cooperate by signing an assignment agreement of any copyright vested in my Contribution to EHA, by issuing a power of attorney to enforce any copyright vested in my Contribution on my behalf, or any other actions required to ensure proper exploitation and/or enforcement of the Contribution, upon EHA's first request.
11. I shall hold EHA and/or its Designee harmless against (a) any claims from third parties that the Contribution infringe the rights of such third parties and/or (b) any claims that result from the use of the Contribution by EHA.
