**EHA Membership**

- ☐ Applicant must have an active EHA membership at the time of application

**EHA Research Grant Agreement**

- ☐ Applicant and the institutions must acknowledge and accept the conditions as set out in the Grant Agreement template

**Fluxx**

- ☐ Update "People" card to ensure personal and institutional information match the ones on the application form

*Note: If your affiliated institution has changed since the first time registered on Fluxx, please let us know. Even if you enter your new institution name manually, the country of your first affiliation will be automatically retrieved from your People card*

**Institutions**

- ☐ Must be academic research centers or proven equivalents in [Europe](#)

*Note: The institution that will support the work of the grant must be an academic research center or proven equivalent. EHA grants are not suitable for grant agreements with national societies*

**Junior Research Grants**

- ☐ Maximum € 150,000 for 3 years
- ☐ PhD or PharmD graduation within four years of the current closing date
- ☐ If applicable, choose Topic-In-Focus Junior Research Grant in Hemoglobinopathies or Precision Hematology on the application form

**Advanced Research Grants**

- ☐ Maximum € 240,000 for 3 years
- ☐ PhD or PharmD graduation four\* to eight years of the current closing date
- ☐ If applicable, choose Topic-In-Focus Advanced Research Grant in Hemoglobinopathies or Precision Hematology on the application form

**Physician Scientist Research Grants**

- ☐ Maximum € 240,000 for 3 years
- ☐ MD interested in a career in research, with an MD or PhD graduation within eight years of the current closing date
- ☐ If applicable, choose Topic-In-Focus Physician Scientist Research Grant in Hemoglobinopathies or Precision Hematology on the application form

**Budget**

- ☐ Do not exceed the maximum per grant category
- ☐ Mandatory costs: your application will be ineligible if it does not include these costs
  - EHA Congress attendance: Maximum €2,000 per year
  - Final Audit report: Maximum €2,000 per year
- ☐ Overhead costs are not covered
- ☐ Provide detailed explanation of each budget item

**Project**

- ☐ Basic and translational lab-based research in hematology
- ☐ Use the template for your project proposal and adhere to page limits
- ☐ If you are applying for a Topic-In-Focus Research Grant in Precision Hematology, you must also complete the additional section of the project proposal template

**Support Letters**

- ☐ Letter from mentor: on institute letterheads (max two pages)
  - For Physician Scientist Research Grant state that at least 50% 'protected time' will be allocated to research
- ☐ Letter from department head: on institute letterheads and must include: (max one page)
  - a statement agreeing to the grant agreement template
  - a statement explaining how to cover overhead costs
- ☐ Institutional Support: on institute letterheads and must include: (max one page)
  - a statement agreeing to the grant agreement template
