EHA Membership

- ☐ Each PI must have an active EHA membership at the time of application

EHA Innovation Grant Agreement

- ☐ Each PI and their institutions must acknowledge and accept the conditions as set out in the EHA Innovation Grant Agreement template

Fluxx

- ☐ Each PI must have an account on Fluxx
- ☐ Only one PI applies on behalf of the collaboration

Note: If your affiliated institution has changed since the first time registered on Fluxx, please let us know. Even if you enter your new institution name manually, the country of your first affiliation will be automatically retrieved from your user card

Consortium

- ☐ Each consortium must have at least 3 PIs
- ☐ At least one PI must be a junior independent group leader (within five years)
- ☐ Must be newly formed within maximum of one year from initially acquired funding

Institutions

- ☐ Must be in at least 3 different countries in [Europe](#)
- ☐ At least one of the PIs must operate in of the following countries: Albania, Armenia, Azerbaijan, Bosnia and Herzegovina, Bulgaria, Croatia, Czechia, Estonia, Georgia, Hungary, Kosovo, Latvia, Lithuania, Moldova, Montenegro, North Macedonia, Poland, Portugal, Romania, Serbia, Slovak Republic, Slovenia, Türkiye, Ukraine.
- ☐ Must be academic research centers or proven equivalents

Note: The institution that will support the work of the grant must be an academic research center or proven equivalent. EHA grants are not suitable for grant agreements with national societies

Scientific Working Groups (SWG)

- ☐ Indicate the PIs that are members of an EHA SWG
- ☐ Alternatively, provide a letter of endorsement from an EHA SWG Chair

Budget and duration

- ☐ Maximum € 300,000 for 2 years
- ☐ No more than 40% of the total grant should be allocated to one member of the consortium
- ☐ Mandatory costs: your application will be ineligible if it does not include these costs
 - EHA Congress attendance: Maximum €2,000 per PI per year

- Final Audit report: Maximum €2,000 per PI
- ☐ Supported costs: personnel costs, lab consumables, small equipment, other
- ☐ Not-supported costs: overhead costs, excessive travel, redundant costs covered by other funding
- ☐ Provide detailed explanation of each budget item
- ☐ Additional funding must be specified on the application
 - o Acceptable from public or philanthropic institutions
 - o Not acceptable from industry or for-profit entities

Project

- ☐ Clinical or translational research in hematology
- ☐ Use the template for your joint project proposal, adhere to page limits and save it as a PDF file and name it: PI1 full name_ProjectProposal.pdf

CVs

- ☐ Maximum two pages per PI
- ☐ Include mandatory information: education and employment, other experience, publications, other projects - indicate whether the PI is junior or senior
- ☐ Combine all CVs into one PDF file and name it PI1 full name_CVs.pdf

Support Letters

- ☐ Department head: on institute letterheads and must include: (max two pages per PI)
 - Institutional commitment and facilities to support the project
 - How the proposed project will fit into the current research of the department
 - A statement agreeing to the grant agreement template
 - A statement explaining how to cover overhead costs
- ☐ Institutional Support: on institute letterheads and must include: (max one page per PI)
 - A statement agreeing to the grant agreement template
- ☐ Combine all letters into one PDF file and save it as PI1 full name_SupportLetters.pdf
