1. Opening and welcome

Welcome to the annual general meeting of EHA by Antonio Almeida, EHA President. Voting explanation as Members could either scan the QR code, or enter the URL in the browser on their devices.

2. Exclusive Presentations by Torsten Haferlach and Matteo Della Porta

- Al implementation studies support opportunities in clinical trials..
- The ethical aspect of using AI remains a vital question. When comparing physicians and Chatbots for online patient queries, the chatbot answers patients' questions very well, including demonstrating empathy.
- Access to healthcare data is needed to accelerate the generation of insights; currently, 97% of healthcare data remains unused.
- Synthetic data is accelerating research in hematology.
- Synthetic data can accelerate clinical research in hematology.
- The dataset of real and synthetic data provided the same results.
- Four different EU countries provide strong support for clinical trials using synthetic data.

3. Annual report 2023 Review

Antonio Almeida, presented a video that summarized the Annual Report for 2023. Highlights were as follows:



- 2023 marked significant transformation for the European Hematology Association (EHA), with a 25% membership growth, ending the year with 6,800 members from over 120 countries.
- The EHA Congress was a key event, attracting over 13,000 participants in Frankfurt, Germany, and receiving more than 2,500 abstracts.
- EHA connected with over 2,700 professionals through various meetings and tutorials worldwide to share scientific knowledge and to create new partnerships.
- The launch of the EHA Guidelines mobile app empowered healthcare professionals globally to access consensus-based treatment and diagnostic guidelines.
- HemaSphere achieved an impact factor of 9.1 in 2022, publishing over 160 manuscripts.
- The EHA Campus expanded significantly by offering 170 comprehensive courses and clinical cases with a 26% growth. EHA funded 26 research projects, mentored 64 research training scholars, and hosted the first in-person retreat for the Lighting the Flame project.
- EHA's involvement in EU policy included working with policymakers to revise key sections of EU pharmaceutical legislation and contributing to the implementation of the Health Technology Assessment Regulation.
- Collaboration was strengthened in 2023, with new relationships formed with key stakeholders, National Societies, and the addition of a new member to the Patient Advocacy Committee.

- Members were able to nominate candidates from January 11, 2024 February 6, 2024.
- 48 applications were received for 2 vacancies.
- Ballot voting opened on April 11, 2024, and closed on May 10, 2024.
- 846 members voted for their most suitable candidate.
