ABOUT THE EHA2024 CONGRESS PLATFORM

The EHA2024 Congress platform is not just a collection of sessions of the EHA2024 program, delivered to you in a traditional format of a daily program with sessions scheduled at a certain timeslot. It is also platform which allows you to watch on-demand sessions of your interest as of June 19 when it is convenient to you. The Congress platform will be open until August 15, 2024.

CODE OF CONDUCT

All participants, speakers, sponsors, and contributors for EHA2024 Congress are required to agree to the User Terms and Conditions as well as the EHA2024 code of conduct below. Organizers will enforce this code throughout Congress. We are expecting cooperation from all participants to establish a safe environment for all.

THE SHORT VERSION

We are dedicated to providing a harassment-free conference experience for everyone, regardless of gender, sexual orientation, disability, physical appearance, body size, race, or religion. We do not tolerate harassment of conference participants in any form. Sexual language and imagery is not appropriate for any conference venue, including talks, workshops, sessions, profiles, social media and any other media. Congress participants violating these rules will be sanctioned and their access to the platform will be terminated, as agreed upon in the **User Terms and Conditions**, without a refund at the discretion of the EHA.

THE LONGER VERSION

Harassment includes offensive verbal comments related to gender, sexual orientation, disability, physical appearance, body size, race, religion, sexual images in public spaces, deliberate intimidation, stalking, following, harassing photography or recording, sustained disruption of talks or other events, inappropriate wording, and unwelcome sexual attention.

Participants asked to stop any harassing behavior are expected to comply immediately.

Sponsors are also subject to the anti-harassment policy. In particular, sponsors should not use sexualized images, activities, or other material.

If a participant engages in harassing behavior, or violate these rules, the participant will be sanctioned and their access to the platform will be terminated, as agreed upon in the **User Terms and Conditions**, without a refund at the discretion of the EHA.

If you are being harassed, notice that someone else is being harassed, or have any other concerns, please **contact Congress organizers immediately** (see above report an incident).

On Friday, June 14, do not miss the <u>Opening Ceremony & Awards</u> and the myriad of educational sessions (Educations session, Science-in-Focus, workshop) all day long.

HOW TO ACCESS THE EHA2024 PLATFORM

For the EHA2024 Congress, the URL will be based on the EHA website, therefore, all URLs behind "ehaweb.org/" should be listed as accessible.

If you are connecting through your institute/hospital network, please inform them accordingly. Make sure that the URL ehaweb.org/ is white-listed.

The EHA2024 Congress platform will open as of June 6!

 <u>As of June</u> 6, you can create your account in the Congress platform, set your profile preferences and browse certain content of the EHA2024 Hybrid Congress. You will receive an email from <u>eharegistration@interplan.de</u> containing a personal access link to the platform. This personal access email will be sent to you only when your registration is complete and to the same email address you registered with. When clicking on the personal access link, you will be re-directed to the platform to set up your account.

Note that if you participated in last year EHA Congress (EHA2023), you may re-use the same account details if the same email address is used for the account as well as for your registration; the system recognizes if an email address has an account.

<u>Until June 13</u>, you will be able to browse the program, save the sessions of your interest in My program and browse certain pages of the EHA2024 Congress program. The Live and Partners & Sponsors pages will be accessible after this date, as the official start of the EHA2024 Hybrid Congress.

The EHA2024 Congress officially starts on Thursday, June 13, 2024.

- <u>As of June 13</u>, the EHA2024 Hybrid Congress officially starts and all pages will be available (according to your status and registration category). You may browse live sessions and check out content from our Partners & Sponsors.
- The EHA2024 Congress platform will remain open until August 15, 2024.

Your Certificate of participation will be sent to you by email (the email you registered with). You can also download your Certificate of participation from the Congress platform as of June 16.

HOW TO REGISTER, CREATE YOUR ACCOUNT & LOGIN

As a first step to access the EHA2024 Virtual Congress Platform, you are requested to **register** and **create your account (as of June 6).**

1. REGISTER

- Only registered participants can access the platform
 - Only registered participants can access the platform. If you have not registered yet, please click <u>here</u>.
 - When you have successfully registered, you will receive a confirmation email from the EHA Registration department.
 - For any questions regarding your registration, please contact eharegistration@interplan.de

2. CREATE AN ACCOUNT (This step is mandatory)

- As of June 6, all registered participants will receive an email from <u>eharegistration@interplan.de</u> containing a personal access link to the Congress platform.
 - <u>Subject line</u>: Your EHA2024 Personal platform access link.
 - This personal access email will be sent to you only when your registration is complete and to the same email address you registered with.
- Read the instructions in your personal access email carefully.
- When clicking on your personal access link, you will be re-directed to the platform to set up your account.
 - The email address you used to register will be automatically prefilled and will be used as your username.
 - During this step, you will be asked to confirm your email address as a security protocol.
 You will receive an email asking you to confirm your email address, this is mandatory to proceed further. Please make sure to check your spam folder.
 - You can setup a password of your choice, you will need this password to return to your account afterwards.
 - Note that if you participated in last year EHA Congress (EHA2023), you may re-use the same account details if the same email address is used for the account as well as for your registration; the system recognizes if an email address has an account.

> We recommend creating your account as soon as you receive your personal platform access link by email.

> This account is separate from the registration account and your EHA membership account.

> You cannot log in to the EHA2024 Congress platform if you have not created an account on this platform via your personal access link.





3. LOG IN TO THE EHA2024 CONGRESS PLATFORM

- After creating your account, you can access the EHA2024 Congress platform and browse the available content.
- We recommend bookmarking this page to access the platform in one click (also save your email and password you will need them when you wish to access the platform).
- At any time, you can update your preferences by accessing your account.

> We advise you to have a good internet connection, a proper device or computer, Google Chrome browser, and a valid registration.

> We recommend using Google Chrome with the newest update; however the platform is also accessible via all common operating system browsers such as Firefox or Edge. Be aware that ad blockers can prevent loading content and opening new tabs. Please ensure that the latest versions of operating systems and browsers are installed.

> For the EHA2024 Congress, the URL will be based on EHA website, therefore, all URLs behind "ehaweb.org/" should be listed as accessible.

If you are connecting through your institute/hospital network, please inform them accordingly. Make sure that the URL ehaweb.org/ is **white-listed.**

HOW TO (RE)-WATCH SESSIONS

You can watch live sessions (LIVE page) or watch on-demand content (PROGRAM) as of June 19.

A live session is broadcasted at a certain time of a certain day (see LIVE overview). All sessions are live broadcasted (LIVE).

On-demand content is released as of June 19 and can be watch at any time. All on-demand sessions can be viewed per presentation in the dedicated session page.



IN-PERSON AND LIVE STREAMED



When the session is **broadcasted live**:

Simply click on the play **p** button on the LIVE page and you will access the session.

When the session is **available on-demand**: Simply watch the presentations available on the page.

Each session has a dedicated page in which you can find:

- Session title
- Presentation titles
- Name of the Chair(s)
- Name of the Speakers
- Q&A options during live sessions as well as on-demand.
- Polling (only possible during live broadcasting)
- Evaluation (if applicable)
- PDFs (extra material if applicable)

WRITTEN Q&A

Each session in the EHA2024 Congress program is equipped with the option of posting Q&A from the audience. The box will appear on the right side of the video. Any Questions posted while on-demand and/or broadcasted live will be visible on the session page.

POLLING

Some sessions in the program contain a polling feature to test the knowledge of the topic at hand. We actively encourage congress participants to share their thoughts with the faculty.

EVALUATION

PARTICIPATION IN Q&A

Via the Congress platform or the Congress App, select the session of your interest and use the Q&A feature to ask your questions to the faculty panel.

CONGRESS APP

In the Congress App, you can find the entire updated congress program, create your own program, find and read all the abstracts and locate the meeting rooms as well as ask questions during sessions.

When opening the platform on your phone, it will asked if you want to continue in the browser or if you want to download the Congress App.
