ABOUT THE EHA2025 CONGRESS PLATFORM

The EHA2025 Congress platform is not just a collection of sessions of the EHA2025 program, delivered to you in the traditional format of a daily program with sessions scheduled at a certain timeslot. It is also a platform which allows you to watch on-demand sessions of your interest as of June 18 when it is convenient to you, gives you the opportunity this year to chat with other Congress participants, and receive program recommendations based on your area of interest. The Congress platform will be open until August 15, 2025.

CODE OF CONDUCT

All participants, speakers, sponsors, and contributors for EHA2025 Congress are required to agree to the User Terms and Conditions as well as the EHA2025 code of conduct below. Organizers will enforce this code throughout Congress. We are expecting cooperation from all participants to establish a safe environment for all.

THE SHORT VERSION

We are dedicated to providing a harassment-free conference experience for everyone, regardless of gender, sexual orientation, disability, physical appearance, body size, race, or religion. We do not tolerate harassment of conference participants in any form. Sexual language and imagery is not appropriate for any conference venue, including talks, workshops, sessions, profiles, social media and any other media. Congress participants violating these rules will be sanctioned and their access to the platform will be terminated, as agreed upon in the **User Terms and Conditions**, without a refund at the discretion of the EHA.

THE LONGER VERSION

Harassment includes offensive verbal comments related to gender, sexual orientation, disability, physical appearance, body size, race, religion, sexual images in public spaces, deliberate intimidation, stalking, following, harassing photography or recording, sustained disruption of talks or other events, inappropriate wording, and unwelcome sexual attention. Participants asked to stop any harassing behavior are expected to comply immediately. Sponsors are also subject to the anti-harassment policy. Sponsors should not use sexualized images, activities, or other material.

If a participant engages in harassing behavior, or violates these rules, the participant will be sanctioned and their access to the platform will be terminated, as agreed upon in the **User Terms and Conditions**, without a refund at the discretion of the EHA.

If you are being harassed, notice that someone else is being harassed, or have any other concerns, please **contact Congress organizers immediately** (see above report an incident).

CONGRESS PROGRAM

To support your user experience, EHA offers a high-quality program with a selection of live sessions which you can find in our live program. In the menu bar, just click on **LIVE** and view the live sessions. If you choose **PROGRAM**, you will be able to search content through pre-selected topics, days or themes.

The EHA2025 Congress starts on Thursday, June 12 with the live broadcast of the sponsored sessions offered by our Partners and Sponsors, followed by the Opening Ceremony & Awards and a variety of educational sessions (Educations session, Science-in-Focus, workshop) all day long.

CONGRESS APP

Download the Congress Mobile App, available in the Apple Store and Google Play.

It only takes one minute to improve your experience at EHA2025. Via the app you can:

- keep the program of the Congress at hand and create your own agenda,
- read all the abstracts,
- check the floorplan and locate the meeting rooms
- exchange knowledge with other experts by asking questions during sessions and using the chat tool.

HOW TO ACCESS THE EHA2025 PLATFORM

For the EHA2025 Congress, the URL will be based on the EHA website, therefore,
all URLs behind "ehaweb.org/" should be listed as accessible.

If you are connecting through your institute/hospital network, please inform them accordingly.

Make sure that the URL ehaweb.org/ is white-listed.

The EHA2025 Congress platform will open as of June 5!

- As of June 5, you can create your account in the Congress platform, complete your profile, set your preferences and browse certain content of the EHA2025 Congress. **You will receive an email from eharegistration@interplan.de containing a personal access link to the platform.** This personal access email will be sent to you only when your registration is complete and to the same primary email address you registered with.

When clicking on the personal access link, you will be re-directed to the platform to set up your account.

Subject line: **Your EHA2025 Personal platform access link.**

*Note that if you participated in last year's EHA Congresses (EHA2022-EHA2024), you may re-use the same account details **if the same email address is used** for the account as well as **for your registration**; the system recognizes if an email address has an account.*

- Until June 12, you will be able to browse the program, save the sessions of your interest in My program and browse certain pages of the EHA2025 Congress program. The Live and Partners & Sponsors pages will be accessible after this date, as the official start of the EHA2025 Congress.

The EHA2025 Congress officially starts on Thursday, June 12, 2025.

- As of June 12, the EHA2025 Congress officially starts, and all pages will be available (according to your status and registration category). You may browse live sessions and check out content from our Partners & Sponsors.
- The EHA2025 Congress platform will remain open until August 15, 2025.

Your Certificate of participation will be sent to you by email (the email you registered with). You can also download your Certificate of participation from the Congress platform as of June 15.

HOW TO REGISTER, CREATE YOUR ACCOUNT & LOGIN

As a first step to access the EHA2025 Congress Platform, you are requested to **register** and **create your account (as of June 5)**.

1. REGISTER

- **Only registered participants can access the platform**
 - Only registered participants can access the platform. If you have not registered yet, please click [here](#).
 - When you have successfully registered, you will receive a confirmation email from the EHA Registration department.
 - For any questions regarding your registration, please contact eharegistration@interplan.de.

2. CREATE AN ACCOUNT (This step is mandatory)

- **As of June 5, all registered participants will receive an email from eharegistration@interplan.de containing a personal access link to the Congress platform.**
 - Subject line: **Your EHA2025 Personal platform access link.**
 - This personal access email will be sent to you only when your registration is complete and to the same email address you registered with.
- **Read the instructions in your personal access email carefully.**
- **When clicking on your personal access link, you will be re-directed to the platform to set up your account.**
 - The email address you used to register will be automatically prefilled and will be used as your username to access the platform.
 - During this step, you will be asked to confirm your email address as a security protocol. You will receive an email asking you to confirm your email address, this is mandatory to proceed further. Please make sure to check your spam folder.
 - You can set up a password of your choice, you will need this password to return to your account afterwards.
 - *Note that if you participated in last year's EHA Congresses (EHA2022-EHA2024), you may re-use the same account details if the same email address is used for the account as well as for your registration; the system recognizes if an email address has an account.*

> We recommend creating your account as soon as you receive your personal platform access link by email.

> This account is separate from the registration account and your EHA membership account.

> You cannot log in to the EHA2025 Congress platform if you have not created an account on this platform via your personal access link.

3. LOG IN TO THE EHA2025 CONGRESS PLATFORM

- **After creating your account, you can access the EHA2025 Congress platform and browse the available content.**
- **We recommend bookmarking this page to access the platform in one click** (also save your email and password - you will need them when you wish to access the platform).
- **At any time, you can update your preferences by accessing your account.**

- > We advise you to have a good internet connection, a proper device or computer, Google Chrome browser, and a valid registration.
- > We recommend using Google Chrome with the newest update; however, the platform is also accessible via all common operating system browsers such as Firefox or Edge. Be aware that ad blockers can prevent loading content and opening new tabs. Please ensure that the latest versions of operating systems and browsers are installed.
- > For the EHA2025 Congress, the URL will be based on EHA website, therefore, all URLs behind **“ehaweb.org/”** should be listed as accessible. If you are connecting through your institute/hospital network, please inform them accordingly. Make sure that the URL ehaweb.org/ is **white-listed**.

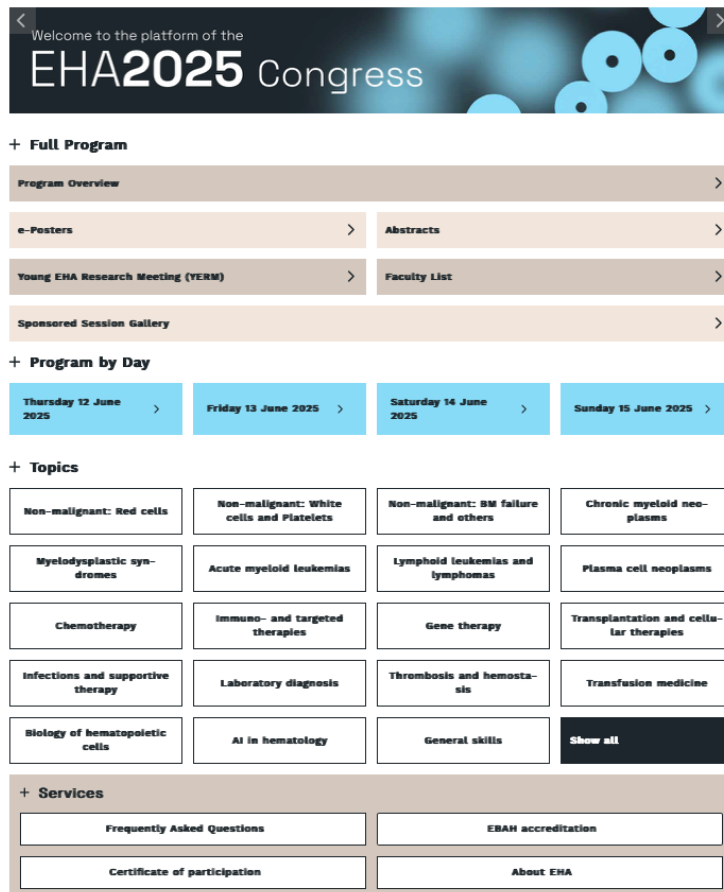
HOW TO EXPLORE THE CONGRESS PLATFORM

MAIN MENU



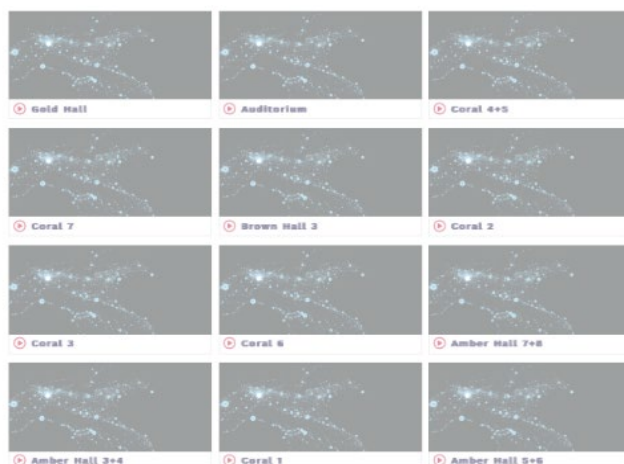
When you enter the platform, you will see the menu bar on top that will direct you to each of the main pillars of the EHA2025 Congress.

LIVE

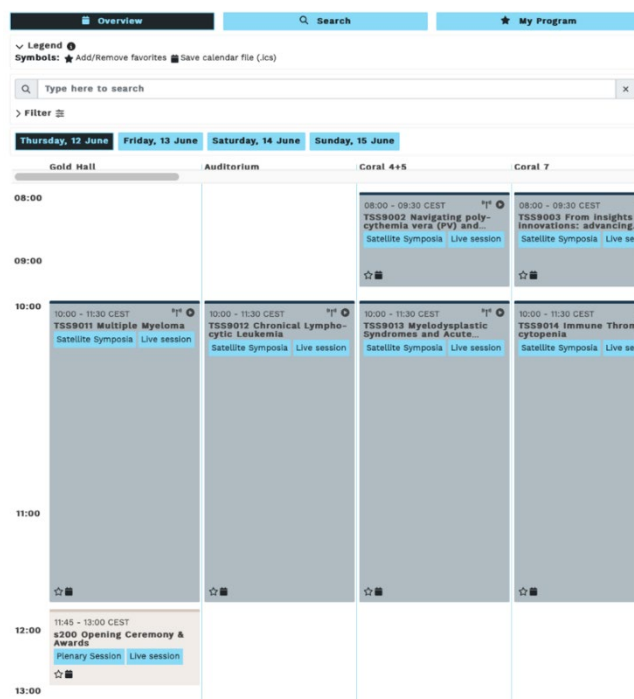


Find a list of currently live EHA2025 sessions here. Click on the play button  in a virtual session hall to access the session.

You will be informed which session is running, when the next session will be live broadcast and/or if there are no more sessions for a particular channel.

All the sessions live broadcast (LIVE) will be available on-demand as of June 18.

PROGRAM

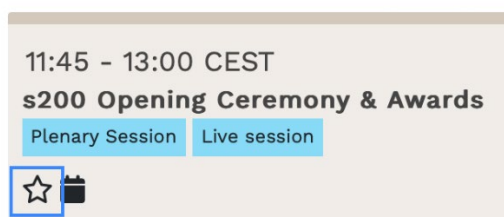



Browse through the program by **category**, per **day** or by **theme**.

SEARCH

The detailed program is accessible selecting the Program Overview.




To create your own program, favorite your session by clicking on the star  next to the session you are interested in. All these favorited sessions will show up in **My Program** which you can access by clicking this symbol on the right side of the screen. You may also retrieve these details in your account 'My EHA2025'.

FILTER

Browse the program by day or by using the filter options: **content, topic, types and rooms**. You may use the search function to search the full program. You may use filters when searching per day unless you use list view. You may apply or reset filters.

LEGEND

Click on the button of your choice to select the session you are interested in.




RECOMMENDATIONS

The areas of disease can be adjusted in your profile. Once you update your areas of disease, this will automatically update your recommended program:



HOW TO (RE)-WATCH SESSIONS

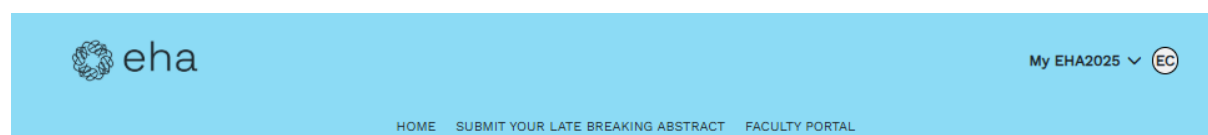
You can watch live sessions (LIVE page) as of June 12 or watch on-demand content (PROGRAM) as of June 18.

A live session is broadcast at a certain time of a certain day (see LIVE overview). All sessions are live broadcast (LIVE).

On-demand content is released as of June 18 and can be watched at any time. All on-demand sessions can be viewed per presentation on the dedicated session page.

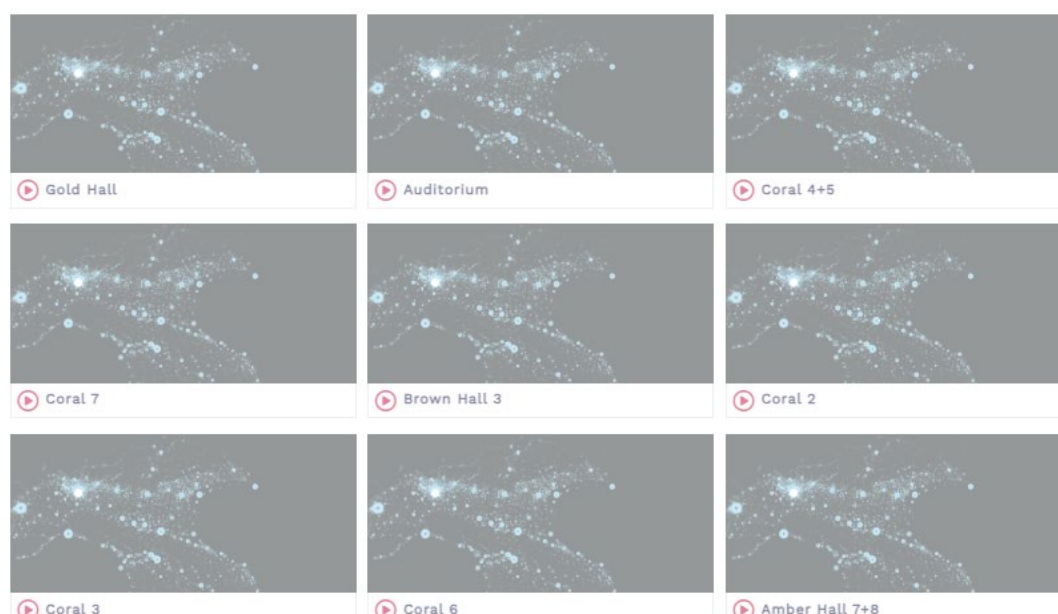
When the session is **broadcast live**:

Click on one of the the hall below to access the livestreamed session.

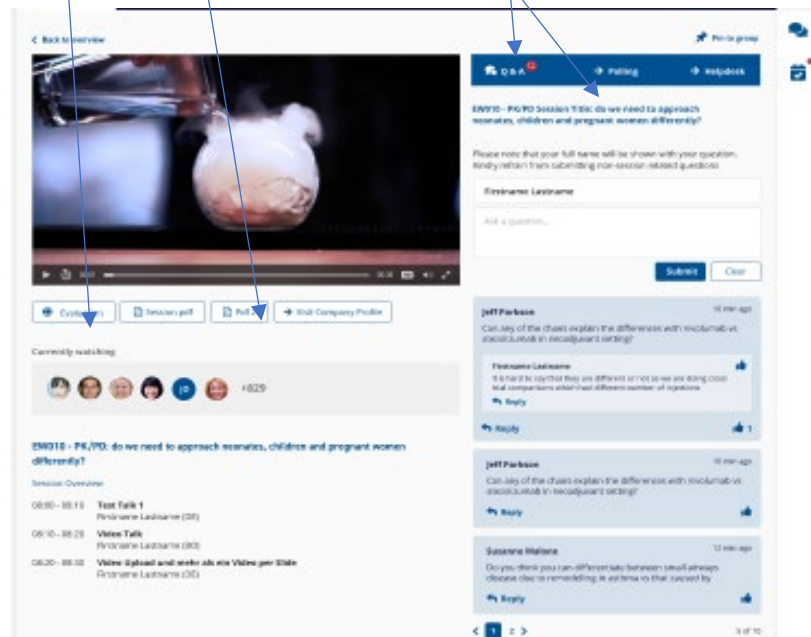


When the session is **available on-demand**:

- Evaluation (if applicable)
- PDFs (extra material if applicable)



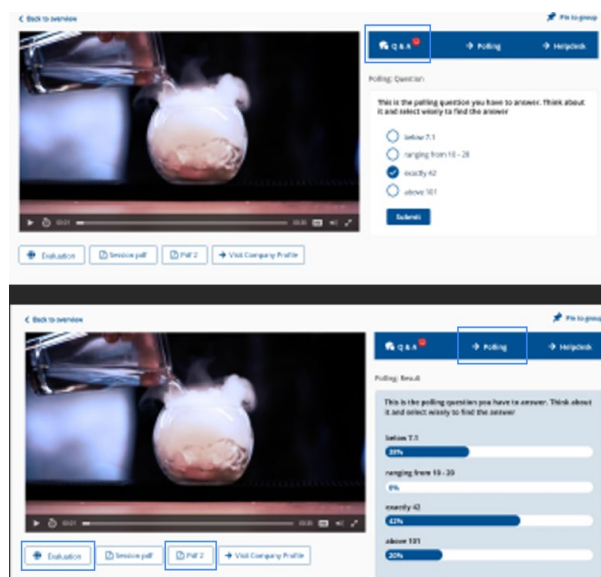
HOW TO PARTICIPATE AND NETWORK

WRITTEN Q&A

Each session in the EHA2025 Congress program is equipped with the option of posting Q&A from the audience. The box will appear on the right side of the video. Any Questions posted while on-demand and/or broadcasted live will be visible on the session page.

POLLING

Some sessions in the program contain a polling feature to test the knowledge of the topic at hand. We actively encourage congress participants to share their thoughts with the faculty.



Confirm settings

This feature is integrated into the platform and can be found in your menu bar and consists out of three main parts:

- **Network:** User list with search and filter options
- **Chat:** Conversation window including the history
- **Settings:** Enable or disable functionalities.



All attendees that have activated the feature in the settings can be found in the network list. This list can be filtered according to certain parameters such as In Person participant, Virtual Participant, Abstract Presenter, Faculty, Country, and can be filtered by A-Z/Z-A. By clicking on the Start Chat button, the user can directly start a chat window (popup). Once you receive a chat message, the chat notification, a small popup can be seen on every page at the top right.
