

## 7th European CAR T-cell Meeting

### Travel Grant Application Guidelines

#### Key dates

Dates	Items
July 11, 2024	Travel grant application opens
November 8, 2024 (23:59 CET)	Travel grant application closes ( <i>extended</i> )
November 20, 2024	Notification of recipients
December 1, 2024 (23:59 CET)	Confirm acceptance

#### 1. Eligibility criteria:

- The applicant is 40 years of age or younger at the time of travel grant application.
- The applicant is an EHA and/or EBMT member or has applied for a membership by October 17, 2024.
- The 2024 membership fee has been paid by October 24, 2024.
- A valid motivation letter with an up-to-date resume/CV.

#### 2. Application Process:

- Interested individuals can submit their application for the travel grant [here](#).
- The travel grant applicant will be asked to confirm eligibility as per the above with a motivation letter (max. 2000 characters)

#### 3. Selection:

- Only applications that meet the eligibility criteria will be considered.
- It is not mandatory to submit an abstract to the 7th European CAR T-cell Meeting, while abstract submitters of the meeting will have the priority to receive the grant.
- There are a limited number of travel grants for both European and non-European applicants.

#### 4. Travel Grant Coverage:

- European grant recipients:
  - Complimentary registration arranged by EHA/EBMT for on-site attendance;
  - Maximum of € 750 for travel arrangements;
  - A reimbursement form must be completed (after the meeting), and the grant amount will be transferred after the meeting based on the attendance obligations.
- Non-European grant recipients:
  - Complimentary registration arranged by EHA/EBMT for on-site attendance;
  - Maximum of € 1500 compensation for travel arrangements;
  - A reimbursement form must be completed (after the meeting), and the grant amount will be transferred after the meeting based on the attendance obligations.

#### 5. Obligations of Grant Recipients:

- Grant recipients must confirm their acceptance by **December 1, 2024**, and provide any necessary documentation to facilitate the arrangements.
- Grant recipients must attend the full scientific meeting (sign-in will be required at the beginning of each day).
- Please note that the grant is non-transferable to other persons or meetings/congresses.
- Travel grant recipients must make their own travel arrangements (i.e. flight/train, hotel accommodation, etc.).

#### 6. Deadline:

- The deadline for travel grant application has been extended to **November 8, 2024 (23:59 CET)**.

#### 7. Notification:

- Applicants will be notified of their travel grant status by **November 20, 2024**.
